FEDERAL TAX DEPOSIT (FTD) INFORMATION NOTICE

OUR RECORDS INDICATE THE IRS RECEIVED AT LEAST DNE DF YOUR RECENT FEDERAL TAX DEPOSITS (FTDS) LATE OR THROUGH AN INCORRECT METHOD. THE LAW GENERALLY REQUIRES THE IRS TO CHARGE A PENALTY FOR LATE OR INCORRECTLY DEPOSITED FTDS. HOWEVER, THE IRS HAS SUSPENDED APPLYING THIS PENALTY UNTIL JULY 1, 1997. IF YOU HAVE ANY QUESTIONS REGARDING THIS NOTICE, PLEASE CALL THE TELEPHONE NUMBER SHOWN ABOVE.

THIS TEMPORARY PENALTY WAIVER APPLIES TO BUSINESSES ENROLLED TO MAKE FTDS THROUGH THE ELECTRONIC FEDERAL TAX PAYMENT SYSTEM (EFTPS) OR REQUIRED TO USE EFTPS BEGINNING JULY 1, 1997. EFTPS IS A FAST, EASY, AND CONVENIENT WAY TO INITIATE FTDS ELECTRONICALLY, WITHOUT PAPER COUPONS, CHECKS, OR TRIPS TO THE BANK.

YOU CAN ENSURE YOU MAKE YOUR FUTURE DEPOSITS ON TIME AND THROUGH EFTPS BY TAKING

THE FOLLOWING ACTIONS:

PLEASE CHECK YOUR RECORDS FOR THE TAX PERIOD SHOWN ABOVE TO SEE WHAT MAY HAVE CAUSED YOUR FTD(S) TO BE LATE OR DEPOSITED INCORRECTLY.

PLEASE REVIEW YOUR ELECTRONIC DEPOSIT PROCEDURES TO BECOME MORE FAMILIAR WITH EFTPS AND HOW TO MAKE YOUR DEPOSITS ELECTRONICALLY.

INFORMATION ON LATE DEPOSITS - TO MAKE A DEPOSIT ON TIME THROUGH EFTPS, YOU MUST INITIATE THAT DEPOSIT AT LEAST ONE DAY BEFORE YOUR TAX DUE DATE. IF YOU ARE USING THE ACH DEBIT PAYMENT OPTION, YOUR FUNDS WILL STAY IN YOUR BANK ACCOUNT UNTIL THE TAX DEPOSIT IS DUE. IF YOU ARE USING THE ACH CREDIT OPTION, YOUR BANK WILL REMOVE THE FUNDS FROM YOUR ACCOUNT AT THE TIME SPECIFIED IN THE BANK'S PROCEDURES.

INFORMATION ON DEPOSITS MADE INCORRECTLY - BUSINESSES THAT ARE REQUIRED TO MAKE ELECTRONIC DEPOSITS, BUT INSTEAD MAKE DEPOSITS USING PAPER FTD COUPONS OR DIRECTLY TO A LOCAL IRS OFFICE, MAY RECEIVE A PENALTY.

BEGINNING JULY 1, 1997, BUSINESSES THAT MADE FEDERAL EMPLOYMENT TAX DEPOSITS OF MORE THAN \$50,000 IN CALENDAR YEAR 1995 ARE REQUIRED TO USE EFTPS TO MAKE ALL FEDERAL TAX DEPOSITS.
